David Purcell uses behavioural measures, otoacoustic emissions, and auditory evoked potentials to improve our basic understanding of the processing of sound in the human auditory system. He is exploring questions such as how do the ears coordinate through the olivocochlear efferent system and how does the brainstem encode vowel formants.

JB Orange studies cognitive-communication, language, discourse and caregivingrelated issues among individuals with multiple forms of neurodegenerative diseases including Alzheimer's disease, frontotemporal dementia, vascular cognitive impairment, amyotrophic lateral sclerosis and Parkinson's disease.

Susan Scollie and her team are working on an analysis of population-level outcomes for children who receive services from an early intervention program, clinical trials of new signal processors for children's hearing aids and collaborating with the NCA's Translational Research Unit to provide evaluation of hearing technologies in adults who have hearing loss.

Homelessness is what policy analysts refer to as a 'wicked problem', with multiple intertwining systems and complexities. The research of Abe Oudshoorn focuses on putting evidence into practice and making real steps toward ending homelessness and mitigating the associated health consequences.

"I think we need to re-conceptualize and manage family care and formal care resources a lot differently." In her caregiving research, Cathy Ward-Griffin attempts to move beyond personal attributes of the caregiver and ask: What is going on in terms of the broader social, economic and political factors that can lead to 'caregiver burnout.

Heather Laschinger is hoping that through her research, nurses will begin to see a more empowering work environment that supports professional nursing practice, leading to less stress and fewer new and experienced nurses leaving the profession.




